**Subject: Result of Jammu and Kashmir Civil Services (Judicial) Examination 2025- Deployment of candidates for Medical Examination thereof.**

**Notification No.: 14-PSC (DR-S) of 2026**

**Dated: 24.02.2026**

Whereas, the Department of Law, Justice & Parliamentary Affairs, vide letter No. Law-JUD/109/2021-10 dated: 07.04.2025, referred 42 posts of Civil Judge (Junior Division), to the J&K Public Service Commission for being filled up through the Competitive Examination; and,

Whereas, these posts were advertised by the Commission vide Notification No. 07-PSC(DR-P) of 2025 dated 14.05.2025; and,

Whereas, J&K Civil Services (Judicial) [Preliminary] Examination-2025, was conducted on **28.09.2025** in which **2974** candidates appeared in full; and,

Whereas, as per the criteria fixed by the Commission, a total of 1016 candidates were declared to have qualified for the Mains Examination vide Notification No. PSC/Exam/S/2025/45 dated: 13.10.2025; and,

Whereas, J&K Civil Services (Judicial) [Mains] Examination-2025 was conducted from 16.11.2025 to 26.11.2025; and,

Whereas, as per the criteria fixed by the Commission, 124 candidates were declared to have qualified for interview vide Notification No. PSC/Exam/S/2026/03 dated: 20.01.2026; and,

Whereas, the candidature of one candidate bearing Roll No. 7901909 was rejected vide notice dated: 30.01.2026 for not producing the EWS Certificate as per the J&K Reservation rules. The candidate was subsequently interviewed on the basis of orders from the Hon'ble High Court; and,

Whereas, the viva-voce of 124 candidates was conducted w.e.f 17.02.2026 to 24.02.2026 at JKPSO Office, Resham Ghar Colony, Bakshi Nagar, Jammu; and,

Whereas, the Commission in its meeting held on 24.02.2026, decided to declare the result of 120 candidates who appeared in the interview by notifying their aggregate marks while publishing a list of 41 candidates to be summoned for Medical Examination in accordance with the relevant rules.

Now, therefore, in pursuance of the provisions contained in Jammu and Kashmir Civil Services (Judicial) Recruitment Rules, 1967 read with SRO No. 5 dated 04.01.1968 and SRO 254 of 2017 dated 20.06.2017, J&K Public Service


Commission (Conduct of Examination) Rules 2022 and J&K Reservation Rules, 2005 (SRO 294) :

- i) The result of 120 candidates, who appeared in the viva-voce (interview) of J&K Civil Services (Judicial) Examination-2025, is hereby notified as per Annexure-I to this notification. The result of four candidates has been withheld.
- ii) Consequent upon (i) above, 41 candidates as per Annexure-II of this notification, on the basis of their aggregate merit in the written examination and viva-voce (interview), have qualified for Medical Examination and are directed to report to the respective Medical Boards constituted/or to be constituted in Government Medical College Jammu & Srinagar for conduct of their Medical Examination as per proforma, in accordance with rules on the subject. The Medical Board, date and venue shall be notified separately.

The candidates recommended for medical examination will have to pay a fee as prescribed, before Medical check-up.

Note:

1. Mere calling a candidate for Medical Examination shall not confer any right on him/her to be recommended for selection.
2. Detailed marks cards shall be available on the website of the Commission after completion of the examination process and after forwarding the select list to the Government for making appointments.
3. The lists notified as Annexure-I & II to this notification are provisional and subject to the outcome of the writ petition(s), if any, pending before any Competent Court of jurisdiction.
4. The selection against one post in SLC Category shall be notified separately.


