In compliance to the directions rendered by the Hon'ble Supreme Court of India in Writ Petition (Civil) No 1245/2025 titled Geeta Rani Vs. Union of India and ors, Hon'ble the Chief Justice has been pleased to direct that the **Sexual Harassment Probe Committee** (Committee No. 24) comprising the following, which is already in place, having been constituted, inter-alia, vide High Court order No. 1762 of 2025/RG dated 29.11.2025, shall henceforth also have the mandate to prevent and redress complaints of sexual harassment and matters connected therewith, in respect of transgender persons, in addition to the matters already entrusted to it:


