- iv. To recommend corrective measures for effective implementation.

- To monitor the implementation and outcomes of the programme in the Union territory.

- To provide overall guidance for implementation of National Dairy Livestock Mission (NDLM) in the District.
- To provide guidance to the Block level National Dairy Livestock Mission (NDLM) Committees in implementation of the programme.
- To monitor the implementation and outcomes of the programme in the district.
- To recommend corrective measures for effective implementation of the programme.

**Terms of Reference:**

- To monitor the implementation of National Dairy Livestock Mission (NDLM) in all the village panchayats and urban areas of the blocks.
- To monitor the implementation and outcomes of the programme in the block.
- To recommend corrective measures for effective implementation of the programme.
