Any Senior Consultant aggrieved with his/her position in the seniority list may file a review petition, along-with documentary evidence, under the relevant provisions of J&K Civil Service (Classification, Control and Appeal) Rules, 1956, within a period of **21 days** from the date of issuance of the seniority. The date of birth recorded in the seniority list shall not be taken as authentic and shall be subject to further verification from the service book/matriculation certificates of the concerned officers.

The said Tentative Seniority List will be available on the official website of Health Department www.hme.jk.gov.in The list shall also be available in the Directorate of Health Services, Jammu/Kashmir.






