**Dated: 25.03.2026**

In view of the revised timelines notified by the Controller General of Accounts, Department of Expenditure, Government of India, the schedule of processing of bills pertaining to SNA SPARSH schemes at the treasuries shall be as under:

- a. Cut-off date & time for submission of bills by DDOs to respective treasuries will be **02:00 PM on 31.03.2026.**
- b. Cut-off date & time for submission of bills by Treasuries to the Cyber Treasury will be **02:30 PM on 31.03.2026.**
- c. Cut-off time for Cyber Treasury to push the Payment files in PFMS will be:
  - i. DBT schemes- **upto 03:00 PM on 31.03.2026.**
  - ii. Non-DBT Schemes- **upto 04:00 PM on 31.03.2026.**
