Subject:- Regular Departmental Action against Mr. Bashir Ahmad Hajam S/o Gh. Nabi Hajam R/o Arampora Ganderbal the then Naib Tehsildar Tangmarg, District Baramulla for commission of offences punishable under section 7 of the Prevention of Corruption Act, 1988 in case FIR No. 05/2021 P/S ACB, Baramulla.

Order No. 28 - FC (Rev) of 2026.

Whereas, Mr. Bashir Ahmad Hajam S/o Gh. Nabi Hajam R/o Arampora Ganderbal the then Naib Tehsildar Tangmarg was arrested by ACB Baramulla in case FIR No. 05/2021, for demanding and accepting an amount to the tune of Rs 30,000/- from the complainant viz Mr. Imtiyaz Ahmad Bhat S/o Gh. Qadir Bhat R/o Chandil, Tangmarg, in lieu of signing of the revenue extracts for alienation of 06 Kanals of land situated at village Chandil Tangmarg; and

Whereas, Deputy Commissioner, Baramulla vide Order No. DCB/SQ/Estt/112-16 dated 07.04.2021 placed the accused official under suspension. This action of DC Baramulla was confirmed by the FCR (J&K) on 07.04.2021 and the official was attached in the office of Divisional Commissioner, Kashmir; and

Whereas, prosecution sanction was granted by the Government vide Order No. No.25-JK-GAD (Vig) of 2023 dated 25.05.2023, which was forwarded to this office by the Revenue Department vide their letter No Rev-Vigl/47 /2021(42803) dated 02.06.2023 with the request to initiate Regular Departmental Action against the accused public servant in terms of J&K Civil Services (CCA) Rules.1956; and

Whereas, the charge sheet was served upon the delinquent official through Divisional Commissioner, Kashmir vide No. FCR-CORD/282/2021(48106) dated 05.12.2024 and the accused has furnish the reply to the charge sheet on 03.01.2025 refuting the allegations leveled against him; and

Whereas, vide this office Order dated 02.04.2025, Additional Deputy Commissioner, Baramulla was appointed as Inquiry officer and Tehsildar Pattan as Presenting Officer to Inquiry into the charges framed against Mr. Bashir Ahmad Hajam, the then Naib Tehsildar Tangmarg District Baramulla to enquire into the matter; and



Whereas, Addl. Deputy Commissioner, Baramulla has submitted his enquiry report vide letter dated 22.05.2025, which is reproduced as under:-

- i. *"It is clear that both the allegations i.e, DEMAND & ACCEPTANCE of bribe do not bear ground and not proved in view of available documents and statements. The complaint seems more like a tool of vengeance than anything else. The allegation of DEMAND is Itself refuted by the complainant and ACCEPTANCE of bribe is also not proved as the tainted money has not been recovered from the pockets of the alleged accused officer and as per his statement no colouration appeared when he was subjected to hand wash test.*
- ii. *However, occurrence of delay in issuing the revenue extracts could not be ignored that has led the complainant to knock the doors of ACB and it can be said that the Naib Tehsildar has acted lackadaisically.*
- iii. *But at the same time this fact cannot be ignored that the said Naib Tehsildar was not only performing the duties of his assigned Nayabat but was also undertaking the routine work of Four other Nayabats which otherwise would have required services of Four Naib Tehsildars and Mr. Bashir Ahmad was attending to these Nayabats singlehandedly. Hence, this delay/derelection of duty can be attributed to the over-burdening of work and deserves to be condoned."*
- iv. *Hence, recommended that charges against the Naib Tehsildar, Bashir Ahmad Hajam could not be established and he deserves to be exonerated from the same and RDA, if any initiated or contemplated to be initiated, be closed as 'not established'.*

Whereas, Deputy Commissioner, Baramulla, vide his letter dated: 01.07.2025 has recommended that the Naib Tehsildar namely Bashir Ahmad Hajam may kindly be exonerated from the charges leveled against him; and

Whereas, the case was examined in this office and Competent Authority (Financial Commissioner, Revenue, J&K) has observed as under:-


- i. *"The I.O in the RDA has concluded that the charges in RDA have not been established. The DC has recommended exoneration. At the same time, ACB has intimated that the charges in the criminal case have been framed on 18.04.25 and matter is listed for prosecution evidence. However, there has been delay in delivery of revenue services and, moreover, there is lack of clarity regarding the sequence of events which can only be decided upon conclusion of the criminal proceedings.*
- ii. *Taking note of these circumstances, it is directed that:*
 - a. *the RDA be closed, with penalty of censure.*
 - b. *suspension revocation be recommended and matter be placed before the Review Committee.*
 - c. *the above shall be subject to the final decision in the criminal case.*



- iii. *In addition, on the administrative side, it is directed that the official shall be suitably utilized by the Divisional Commissioner Kashmir till further orders."*

Now, therefore, in terms of Rule 30 of J&K Civil Services (Classification Control and Appeal) Rules, 1956, the penalty of censure is hereby imposed upon the official Mr. Bashir Ahmad Hajam the then Naib Tehsildar Tangmarg, Baramulla presently attached in the office of Divisional Commissioner, Kashmir.
