Subject: Provisional Select List of candidates for the various posts under Mission YUVA District Kathua.

NOTICE

Whereas, an advertisement notice was issued from this office vide endorsement no: DDCK/Adm/2025-26/3667-75, Dated: 16-03-2026 for filling up of various posts under Mission YUVA, with the last date for submission of application forms fixed as 24-03-2026;

Whereas, in response to the aforementioned advertisement, a total of 79 applications were received;

Whereas, the system had auto calculated the marks of the candidates on the basis of applications filled by them and it was found that out of all eligible 79 candidates, 50 were found qualified (Minimum Points required 40) as per the guidelines of Mission YUVA;

Whereas, after the preliminary verification of the documents of all the candidates, 02 no. of candidates applied twice and hence total no. of candidates is arrived at 77 instead of 79 and qualified candidates from 50 to 48 as per set criteria mentioned in guideline Clause No. 4.3.1; and

Whereas, the list of not qualified/ineligible candidates was published in public domain vide no. DECC/K/2026-27/89-92 dated 16.04.2026 for inviting objections if any to the list;

Whereas, in response to the above notice, no objection was received. Hence, the total no. of qualified candidates remains unchanged;

Whereas, during the meeting of District Selection Oversight Committee, the documents of all the qualified candidates were placed before the committee and out of 48 qualified candidates, only 17 candidates met the selection criteria as per the approved guidelines of Mission YUVA for hiring of SBDU & BHDs;

Whereas, the Interview of the qualified candidates was scheduled on 24-04-2026 that was notified vide Interview Notice No: DE&CC/K/2026-27/190-210 dated 21-04-2026 and was held at DC Office Kathua.

Now, therefore, all other relevant parameters, the list of candidates who called for interview on 24.04.2026 is enclosed herewith as **Annexure-"A"**.

Further, on the basis of performance in the interview, weightage earned in respect of the academic merit, qualifications, experience and total score achieved as per notified parameters of the candidates are figuring in **Annexure-"B"** to the notification are provisionally selected against the available posts.
