Subject: Suspension of AERO/BDO for Poor Performance in Revision of Panchayat Electoral Roll-2026 w.r.t 01-04-2026 as qualifying date.

Whereas, Sh. Mohtshim Hanief Serving as Assistant Electoral Registration Officer (AERO)/Block Development Officer Plangher, was entrusted with the responsibility of supervising and ensuring the timely and accurate revision of the Panchayat Electoral Roll;

Whereas, it has been observed that the progress of your block regarding ongoing revision of panchayat electoral roll 2026 is very poor for which you were intimated accordingly vide this Officer No. DDEO/R/2026-27/82-93 Dated 10-04-2026;

Whereas, vide this office letter No. DDEO/R/2026-27/142-52 dated 17-04-2026 all the EROs/AEROs have been intimated regarding poor performance of Revision of Panchayat Electoral Roll 2026 as the commission has taken serious note of it and bench mark of 4% addition in the electoral Roll has been fixed;

Whereas, during special camps which were held on 25-04-2026 and 26-04-2026 google meet held with District Panchayat Election Officer (Deputy Commissioner) Rajouri with EROs/AEROs were also warned to bear the benchmark set for this revision exercise is to be achieved within a stipulated period ;

whereas, it has been observed that you have failed to discharge the assigned duties with due diligence and efficiency, resulting in significant lapses, including but not limited to the following;

- i) Incomplete and delayed revision of electoral rolls,
- ii) Failure to adhere to prescribed guidelines and timelines issued by the State Election Commission,
- iii) Lack of proper supervision over field-level functionaries,

And whereas, such negligence and dereliction of duty have adversely affected the integrity and reliability of the Panchayat Electoral Roll revision process;

Now, therefore, in exercise of the powers vested under the relevant service rules and in the interest of maintaining administrative discipline, Sh. Mohtshim Hanief Serving as Assistant Electoral Registration Officer (AERO)/Block Development Officer (BDO) Plangher, is hereby placed under suspension with immediate effect, pending further inquiry into the matter.

During the period of suspension, the said officer shall remain attached to the office of Assistant Commissioner Panchayat Rajouri and shall not leave the headquarters without prior permission.
