The Mentor Officers shall monitor all activities and initiatives of District Administration, related to the Nasha Mukt Bharat campaign on the following matters:

- i) Awareness & IEC Activities- Awareness campaigns in schools, colleges, panchayats and urban wards through rallies, seminars, street plays, and social media outreach.
- ii) Collaborations with stake holders for a sustained messaging and continued outreach.
- iii) De-addiction services provided by Health Department.
- iv) Enforcement & prevention conducted by the Police and Excise Departments.
- v) Identification of substance users through surveys and outreach and their subsequent rehabilitation.
- vi) Referral of substance users to De-addiction centers and their Counseling and rehabilitation services and monitoring follow-up and reintegration of recovered individuals.
- vii) Training programmes for teachers, ASHA/Anganwadi workers Volunteers and peer educators for building a network of "Nasha Mukt Volunteers" at village/ward level.
- viii) Community engagement through involvement of Panchayati Raj Institutions, Youth clubs, NSS/NCC units, Religious and community leaders to ensure and promote community-led initiatives for drug-free villages/wards.



- ix) Data reporting by district administration on awareness activities conducted, individuals identified and treated, community participation.
- x) Conduct and organizing of Anti-drug pledge campaigns, and intensive awareness weeks in high-risk areas and hot-spots by district administration.

Further, the Mentor Officers shall conduct monthly Impact assessment of the campaign for evaluation based on measurable outcomes and report generation for corrective measures. The District Administration shall plan, execute all activities regarding the Nasha Mukh Bharat Campaign in coordination with the Mentor Officers.



