Subject: Implementation of Vibrant Villages Programme-II (VVP-II).

Government Order No.834–JK(GAD) of 2026,
Dated:27.04.2026.

With a view to ensure comprehensive and sustainable development of villages located along the International Border (IB) and the Line of Control (LoC) and the launch of Vibrant Villages Programme–II (VVP-II), the officers indicated in **Annexure** to this order are hereby assigned the Vibrant Villages as shown against each for overseeing the implementation of programme during the month of May and June, 2026.

The Deputy Commissioners concerned shall facilitate the visits and provide necessary logistical and administrative support. All Line Departments shall extend full cooperation and furnish requisite data and information as required.

The indicative responsibilities of the officers shall include the following:

- (i) Undertaking field visits to the allotted Vibrant Village(s);
- (ii) Reviewing the status of infrastructure, service delivery, and implementation of ongoing schemes;
- (iii) Identifying gaps in critical sectors, including connectivity, health, education, livelihoods, and digital access;

- (iv) Interacting with local stakeholders, Border Guarding Forces, residents, and civil society organizations;
- (v) Ensuring convergence of Central and Union Territory sector schemes;
- (vi) Guiding the Village Nodal Officers/District Administration in the preparation of comprehensive Village Action Plans based on baseline data and gap analysis.

The officers shall submit a detailed report, with respect to the parameters as indicated above, to the Planning, Development and Monitoring Department by 30th of June, 2026.
