**Sub:- Seizure of TATA Mobile Bearing Registration No. JK02B-6463 alongwith 20 deodar green scants = 54.44 Cft and suspension of I/c Beat Guard Jai 2<sup>nd</sup> beat (Co.13-35/Jai); reg.**

Whereas, on a specific input, on 22-04-2026 at about 2.40 AM, a joint team of FPF personnel and Territorial staff of Neru Range comprising B. O. Duggi-I, Beat Guard Co. 1-3/N & Beat Guard Co. 9-12/N seized the TATA Mobile Bearing Registration No. JK02B-6463 loaded with 20 deodar green scants = 54.44 Cft which was found parked on road at village Jalga in Comptt. 3/N.

Whereas, I/c Beat Guard Jai 2<sup>nd</sup> beat (Co.13-35/Jai) was found on the way from Chinta to Ghati Morh side at about 2.30 AM in his personal vehicle (VagonR) in which a mechanical cutter packed in a bag was detected by the Joint Team.

Whereas, source of timber seized in the particular case is yet to be ascertained whether it has extracted from jurisdiction of Chiralla Range or Neru Range, but movement of I/c Beat Guard, Jai 2<sup>nd</sup> beat (Co.13-35/Jai) in night hours in the same area is suspicious.

Therefore, pending enquiry into the matter, Sh Mushtaq Ahmed Batt, MTS (Mali) I/c Beat Guard Jai 2<sup>nd</sup> beat (Co.13-35/Jai) of Chiralla Range adjoining Beat of Comptt. 3/N is hereby placed under suspension with immediate effect and attached in Divisional Office, Bhadarwah.

Suspension allowance as admissible under rules is allowed to be paid to the suspended official during his suspension period.
