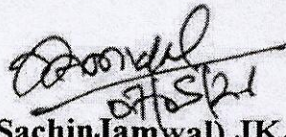

1. Whereas, the J&K Public Service Commission conducted the **Written Test for filling up of posts of Assistant Professor [Fine Arts, Music & Languages and Fine Arts (School of Architectures)] in Higher Education Department, on 18.04.2026; and**
2. Whereas, the Provisional Answer Key(s) was notified and uploaded on the official website of the Commission for information of the candidates on 18.04.2026, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer objection on the prescribed proforma to the Controller of Examinations upto 22.04.2026 (5:00 p.m.) along with documentary proof /evidence and the fee of Rs.500/- per question; and
3. Whereas, in response to the said notification, an objection was received by the J&K Public Service Commission against Provisional Answer Key issued in respect of Assistant Professor (Fine Arts, Music & Languages). However, no objection has been received against Assistant Professor [Fine Arts (School of Architectures)]; and
4. Whereas, the objection was referred to the Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Expert opinion; and
5. Whereas, the Experts have recommended changes in the Provisional Answer Key in respect of the said paper;

Now, therefore, in view of the above and on the basis of opinion of the Experts, it is hereby notified that:-

- a) The changes recommended by the Experts are hereby adopted and the Final Answer Key(s) are annexed to this notification as **Annexure A and Annexure B** in respect of **Fine Arts, Music & Languages and Fine Arts (School of Architectures)**. In terms of Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the deleted questions ***shall be individually added to the marks secured by the individual candidate to ensure that the mark(s) allocated for the question paper as a whole remain unchanged*** at the time of calculation/compilation of award sheet before the declaration of the result;
- b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.

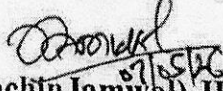

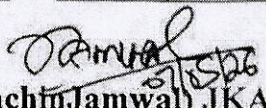
