**Subject: Cancellation of Transfers/Postings and Attachment Orders issued by the then Director, Health Services, Jammu.**

**Government Order No. 422 -JK(HME) of 2026**  
**Dated: 15 .05. 2026**

**Whereas,** it has been observed that a considerable number of transfers/postings and attachment orders in respect of Medical officers, Non-Gazetted, Paramedical and Class-IV and other staff members were issued by the then Director, Health Services, Jammu during the month of April, 2026; and

**Whereas,** now Director, Health Services, Jammu vide communications dated 11.05.2026 has furnished details of such transfers/postings and attachment orders issued during the period from 15.04.2026 to 30.04.2026; and

**Whereas,** the matter has been examined in the Department and considering the timing and volume of the orders issued during the aforesaid period, it has been deemed appropriate in the interest of administration and smooth functioning of healthcare institutions to review the said orders.

Now, therefore, in the interest of administration and patient care, it is hereby ordered that transfers/postings & attachment orders issued by the then Director, Health Services, Jammu in respect of Doctors, Non-Gazetted, Paramedical and Class-IV and other staff members during the period from 15.04.2026 to 30.04.2026 as mentioned in **Annexure-A** are hereby rescinded ab-initio with immediate effect

Consequent upon, all such employees shall continue to perform their duties at their previous places of posting, as existed prior to issuance of the aforesaid orders. Any non-compliance by the officers/officials shall be viewed seriously and disciplinary action shall be initiated against the delinquent officers/officials. The concerned DDO shall also be held responsible for any non-adherence to this Government Order.

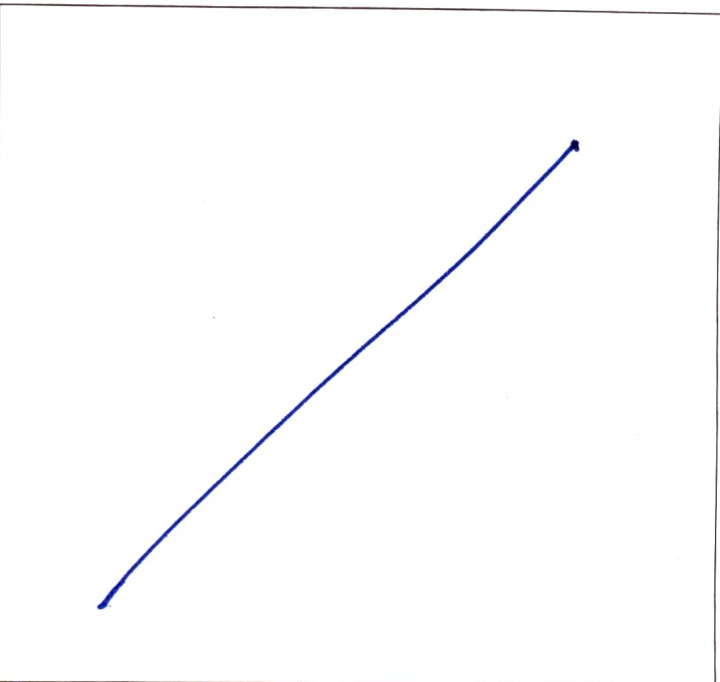
