In continuation to the Government Order No. 119-PW(R&B) of 2026 dated 10.04.2026 read with Government Order No. 136-PW(R&B) of 2026 dated 22.04.2026 & Government Order No. 146-PW(R&B) of 2026 dated 24.04.2026, sanction is hereby accorded to the placement of following Degree holder In-charge Assistant Executive Engineers as In-charge Executive Engineers (Civil) in their own pay and grade, on stop-gap basis, with immediate effect, as prescribed in the J&K Engineering (Gazetted) Service Recruitment Rules, 1978, amended vide SRO 297 of 2006, till the posts are filled from the eligible engineers of the relevant quota:

The above arrangement shall be subject to the following conditions:

- That this arrangement shall be an interim one, purely temporary (look after basis/stop gap) in nature, without conferring any preferential right to claim substantive promotion/regularization/confirmation, which shall be made strictly as per the Recruitment Rules and as per other eligibility conditions prescribed thereof through DPC/J&KPSC.*
- That this arrangement shall be subject to outcome of writ petition(s) pending, if any, before any Competent Court(s) of law.*
- The arrangement shall be reversible without any prior notice, if any adverse report is received from any agency and also any superior claim of any left out Engineer of the relevant quota, if found genuine, later on.*

Consequent upon the above placements, these engineers shall continue at their present place of posting till further orders.
