**Subject: Implementation of Multi-Factor Authentication (MFA) through Sandes on JK BEAMS Portal.**

This is for the information of all concerned that, in order to further strengthen the security framework of the JK BEAMS Portal, Multi-Factor Authentication (MFA) integrated through Sandes (SMS-based authentication) has been successfully implemented in the live environment.

Accordingly, all Director Finances, Director Plannings, Financial Advisors (FAs), Chief Accounts Officers (CAOs), Accounts Officers (AOs) Drawing & Disbursing Officers (DDOs), Maker/Checker users associated with the JK BEAMS Portal are advised to ensure strict compliance with the following instructions:

- The Maker/Checker shall be solely responsible for the secure handling, confidentiality, and proper use of their login credentials.
- Login credentials, one-time passwords (OTPs), and all authentication-related information must remain strictly confidential and must not be shared with any unauthorized person under any circumstance.
- All users must ensure that their registered mobile numbers linked with Sandes are active, valid, and accessible for receiving authentication messages.
- Any discrepancy, authentication failure, or technical issue shall be immediately reported to the official email Id: **dg-budget@jk.gov.in/**

It is further emphasized that the respective Maker/Checker shall be held solely accountable for any transaction or activity undertaken using their credentials.


