**Subject: Sanction of 'Permanent Advance or Imprest' in favour of Deputy Commissioners (Competent Authority for Land Acquisition).**

**Government Order No. 162-PW(R&B) of 2026**  
**Dated: 11-05-2026**

In terms of Rule 322 of GFR, sanction is hereby accorded for Permanent Advance or Imprest in favour of Deputy Commissioners (Competent Authority for Land Acquisition) to meet out urgent exigency expenditures related to the land acquisition to the extent of Rs 20.00 lakh or 2% of funds deposited by the Regional Officer, MoRTH, Jammu against the land acquisition in the said District, whichever is less.

The advance sanction shall be subject to the following conditions:

1. The advance drawals to be made shall be debitible to Detailed Head: 037-Professional & Special Service Charges subordinate to the classification 3054-04-337-0099-6114 (Administrative Charges).
2. The advance so sanctioned shall be operative in the form of a revolving fund after the re-coupmnt of previous amount by way of rendition of red account to the PAG.
3. The drawals shall be made after fulfillment of all codal formalities as per GFR and in no way the treasury officer shall entertain the bill unless it is annexed with a certificate issued by Pr Accountant General certifying the adjustment/rendition of red account of previous advance.
4. The financial and accounting operation of the advance (i.e. drawal, rendition of red account, reconciliation and audit issues etc) shall be the sole responsibility of Accounts officer posted in the Deputy Commissioner's office.
