Subject: Self-Enumeration by Government Employees under Census 2027.

Order No. 92 – DSEOJ of 2026
Dated 19 .05.2026

Whereas, the Government of Jammu & Kashmir, Planning Development & Monitoring Department, vide Circular No. 03-(PD&MD) of 2026 dated 27.03.2026 and subsequent communication dated 12.05.2026, has directed active participation of all Officers/Officials in Self-Enumeration under first phase of Census 2027, i.e House Listing and Housing Census Operations (HLO) through the official portal <https://se.census.gov.in>.


Whereas, Self-Enumeration for Jammu & Kashmir has been notified from **17th May 2026 to 31st May 2026** and House listing Operations notified from **1st June 2026 to 30th June 2026**.

Now, therefore, in the interest of ensuring effective implementation of Census 2027, it is hereby ordered that:

1. All Government employees/officials working within District Jammu shall complete Self-Enumeration for their household through the official Census Self-Enumeration Portal i.e. <https://se.census.gov.in> during the notified period.
2. At least one member from each household of every employee/official shall complete the Self-Enumeration process and generate the Self-Enumeration ID (SE ID).
3. All Drawing & Disbursing Officers (DDOs)/Heads of Offices shall ensure strict compliance of these instructions by all employees under their administrative control.
4. DDOs shall obtain confirmation/record of Self-Enumeration along with generated SE ID from the employees concerned before processing salary bills for the month of May 2026.
5. The Treasury Officers concerned shall seek a certificate from the respective DDOs stating that all employees/officers under their control have completed registration under Self-Enumeration and generated SE IDs before processing salary bills for the month of May 2026.
6. In case of non-compliance, the salary of the concerned employee for the month of May 2026 shall not be drawn.
7. The steps for Self-Enumeration are as under:
 - I. Visit the official portal: <https://se.census.gov.in> and select State/UT.

- II. Register Household by entering the name of Head of Household and mobile number.
- III. Verify OTP and select preferred language.
- IV. Enter location details including District, PIN Code and locality.
- V. Mark residence location on map and save.
- VI. Fill complete House Listing & Housing Census form online.
- VII. Review and verify all entered details carefully.
- VIII. Submit the form and generate Self-Enumeration ID (SE ID).
- IX. Preserve and share the generated SE ID with the Enumerator during field verification.

This order shall come into force with immediate effect.
