This sanction shall be subject to the following conditions:

1. The delegated/designated DDOs shall operate only such object heads/schemes under Demand No. 51 (Police) as may be specifically authorized by the Home Department, J&K from time to time.
2. The concerned DDOs shall ensure strict adherence to the provisions of General Financial Rules (GFRs), Delegation of Financial Powers Rules

(DFPR), instructions/guidelines issued by the Ministry of Home Affairs/ Ministry of Finance, Government of India and Home Department, Government of J&K and the Office of the Internal Financial Advisor (Home) from time to time.

3. The DDOs shall be personally responsible for verification, genuineness and admissibility of claims before processing payments through PFMS.
4. All payments shall be made only to eligible vendors/beneficiaries through PFMS after due verification and completion of codal formalities.
5. The concerned DDOs shall maintain proper records, vouchers, audit trail, utilization certificates and other relevant documents for audit/inspection purposes.
6. The delegation of DDO powers shall not, in any manner, amount to delegation of financial powers beyond the approved budget allocation and authorization issued by the competent authority.
7. The expenditure shall be incurred strictly within the approved budgetary provisions and for the purpose for which funds are authorized/allotted.
8. The DDOs shall ensure compliance with all audit observations and shall furnish requisite reports/information to the Home Department, J&K and other authorities, as and when sought.
9. Any irregularity, excess expenditure, unauthorized payment or violation of financial rules/instructions shall be the personal responsibility of the concerned DDO.
