Subject: Cancellation order to M/s Ani Technologies Private Limited (OLA).

Whereas, M/s ANI Technologies Private Limited (OLA) having Registered office at Regent Insignia, 414 3rd Floor, 414, 3rd Floor, 4th Block, 17th Main, 100 Feet Road, Koramangala, Bangalore, Karnataka, India with Branch office at ABC Building, New Plot, Jammu, Near Krishna Building (Looks Salon), J&K applied for Motor Vehicle Aggregator License;

Whereas, Motor Vehicle Aggregator License no. 0001, dated 21.09.2023 was granted in its favour with the following conditions: -

The licensee shall comply with all the conditions as laid down under Rule 8-14 of S.O. 453 dated 29.08.2023 before start of operations within six months of date of issue of License if the Licensee fails to do so, License so issued shall be deemed to have been cancelled.

Whereas, as per the conditions laid down in the aforesaid licence, the registered office of M/s ANI Technologies Private Limited (OLA), situated at ABC Building, New Plot, Jammu, near Krishna Building (Looks Salon), J&K, has not been operationalized and the company has not commenced its operations from the said premises;

Whereas, the status of the Branch Office has been recorded as "Non-Functional" as the office was found to be non-traceable during the inspection conducted by the team of the Regional Transport Officer, Jammu, on 13.12.2024;

Whereas, three show cause notices/Suspension Notice in this regard vide no. TCJK-Gen/509/2023-07/4862-66 dated 01.12.2025, TCJK-Gen/509/2023-07/3054-58 dated 02.04.2026 and TCJK-Gen/509/2023-07/3777-82 dated 30.04.2026 were served to the organisation;

Whereas, no reply to these notices have been received by this office till date;

Now, therefore, in view of the facts and circumstances stated hereinabove, I, Vishesh Paul Mahajan, JKAS, in exercise of the powers conferred upon me vide S.O. 453 dated 29.08.2023, and under Rule/Section 19(1) of the Motor Vehicle Aggregator Rules, 2023, hereby cancel Motor Vehicle Aggregator License No. 0001 dated 21.09.2023, with immediate effect.
