Terms of Reference:

- i. To approve projects and accord administrative approval of Detailed Project Reports (DPRs)
- ii. To monitor Mission including progress of projects, capacity building, IEC campaign and reform implementation, etc.
- iii. To recommend proposals for release of installment of funds for projects to the Centre.
- iv. To finalize UT and ULB share of funds for project implementation.
- v. To allocate and release of Central and UT share of funds to ULBs in time.
- vi. To encourage and facilitate start-ups and private entrepreneurs, PPP to participate for technology demonstration projects.
- vii. To approve plans for capacity building, issue notifications, etc. for speedy implementation of reforms.
- viii. To issue directions to the UT Mission Director, Urban Challenge Fund on Operations & Maintenance of urban infrastructure projects under the Mission.
